# Welcome and Announcements (Slides 3-4)

Speakers: Erica Rosemond and Ruth O'Hara

E. Rosemond (filling in for Michael Kurilla) welcomed the members of the Steering Committee (SC) and facilitated the Steering Committee call.

- A Principal Investigator (PI) must be officially named on an active grant currently awarded to a CTSA Hub, and the award must have 3 years remaining.
- A PI must not have served on the SC since December 2018

# Survey Request from *Catalyzing CTSA Hubs as Partners in LHS* (an "informal" Working Group) (Slides 5-6)

Speaker: Kerry James

#### Presentation summary:

K. James shared details about a proposed survey to collect information about whether and how CTSA hubs are participating in and/or supporting learning health system (LHS) activities of a health system or healthcare organization. The purpose is to gain a more comprehensive understanding of whether, and how, the CTSA Consortium is using its unique expertise to directly support improvements in clinical care and healthcare provider organizations. The survey developers would like to disseminate the survey in early 2025 and are requesting SC approval.

#### Questions and Discussion:

- D. Ford noted the Hub point of contact (POC) responsible for completing the survey should be the Principal Investigator (PI), who will be best positioned to answer questions appropriately.
  - K. James agreed, stating the Hub Administrator likely would be the one to receive it, and that person could help identify the best person to complete the survey.
  - A. Carnegie asked if the survey would include definitions to help a Hub Administrator distribute the questionnaire appropriately.
    - K. James thanked A. Carnegie for this suggestion and will pass it along so the team can develop a preamble.
    - R. O'Hara suggested a more complete definition than that from the National Academy of Medicine Leadership Consortium would be helpful.
- V. Garovic asked about the format of the questionnaire.
  - K. James replied, stating it would be a REDCap questionnaire with closed response options rather than open-ended text response options.
- R. O'Hara suggested the team revise the questions, which seem to lack detail.
- R. O'Hara asked SC members to review the questionnaire, which C. Mark previously distributed, and provide suggested feedback.

WG Proposal Review / Voting Process (Slides 7-25)

Presentation Summary:



C. Mark provided details needed by SC members so they can review Working Group (WG) proposals for Cycle XIII from October 7 to November 11. Feedback gathered during the review will inform discussions leading up to the official vote on December 9 to select 3 new WGs to begin operating in January 2025.

She shared a reminder about all current WGs, including the 2 scheduled to sunset at the end of this year, before explaining how to log in to the <a href="CCOS website">CCOS website</a>, access the <a href="Steering Committee">Steering Committee</a> <a href="Landing Page">Landing Page</a>, complete a Conflict of Interest (COI) check, and evaluate and rate the proposals according to a 1-5 point scale.

She encouraged all SC members to review the proposals and directed SC members to contact the <a href="CCOS Support Team">CCOS Support Team</a> with any questions.

- V. Garovic asked for confirmation that a SC member's involvement with one of the proposed WGs is a COI.
  - C. Mark confirmed and suggested the SC member skip that proposal and review others.

# **DEIA Update, followed by Discussion (Slides 26-34)**

# **Presentation Summary:**

L. Carter-Edwards and T. Nguyen shared statistics about the Diversity, Equity, Inclusion, and Accessibility (DEIA) Enterprise Committee (EC), including objectives, Hub membership, meeting attendance, accomplishments, and goals. They then asked the SC for feedback and guidance in supporting DEIA in translational research in the current political climate.

#### Accomplishments, Goals, and Priorities:

- Presentations at EC meetings on DEIA alignment and possible name change to "Inclusive Excellence"
- Surveys to gauge climate, concerns, and needs at Hubs.
- Cross-Hub sharing of DEIA practices and challenges by increasing understanding of the Learning System Accountability Framework
- o Equity, inclusion, and accessibility assessment plan
- Catalog of CTSA DEIA best practices

#### Questions for the SC:

- Advice for next steps around supporting DEIA in the CTSA?
- o How best can Hubs conduct DEIA translational science in political climate?

#### Questions and Discussion:

• R. O'Hara commented her Hub in California has focused on inclusivity in the context of more treatments for more people, noting its importance regardless of nomenclature.



- The speakers thanked her for sharing this approach. T. Wun noted using such language should assist with complying with any local law suits pushing back against the idea of DEIA.
- R. Urban noted Texas has a state law prohibiting DEIA initiatives at public universities
  and it has been challenging thinking through ways to implement federally funded DEIAbased awards. Lawyers have suggested removing specific DEIA terminology from
  websites.
- The presenters noted the EC considered changing their name to removed DEIA wording but decided against the idea. However, the EC welcomes feedback from the SC. Regardless of the nomenclature and local political climates, EC has continued. L. Carter-Edwards suggested the SC provide an official endorsement statement, which could be shared locally by those concerned about push-back at their institutions.
  - o T. Wun urged caution with rebranding.
  - R. O'Hara cautioned against taking a firm stance against potential renaming, noting the work would remain the same regardless of whether nomenclature is politically correct.
